## **Course Director Duties**

A course director is responsible for the overall design and administration of a course. Duties include:

- Write syllabus
- Oversee content on learning management system (Canvas)
- Set course goals
- Set course objectives
- Set course content
- Plan and conduct assessments/evaluations
- Write exam questions (or delegate to appropriate faculty)
- Develop rubrics as needed
- Proctor exams
- Plan instruction (content and instructional methods)
- Schedule learning sessions
- Oversee/lead/conduct learning activities
- Ensure appropriate learning materials are available to students
- Order textbooks
- Confirm final exam scheduling with registrar
- Set grade scale

- Determine grade weighting, when appropriate
- Set course grading policies
- Set remediation policy and conduct remediation
- Set attendance policy in alignment with SOD policies
- Manage student accommodation requests
- Maintain office hours/be available to students
- · Respond to student concerns
- Ensure humanistic and inclusive educational environment
- Evaluate outcomes of the course
- Continuously improve course based on outcomes and developments in subject area
- Ensure course material is appropriate to curriculum and supports SOD competencies
